# THE STUKELEYS PARISH COUNCIL NEWS

## From the meeting held on the 5<sup>th</sup> February 2015

At the Parish Council Meeting held at Little Stukeley Village Hall on the 5<sup>th</sup> February 2015, 8 Parish Councillors, 1 County Councillor, 5 residents and the Parish Clerk were in attendance.

One resident was concerned about a pot hole in Beech Avenue, Great Stukeley which has been repaired on several occasions. Highway problems and pot holes can be reported directly to CCC Highways on 0845 0455212 or via [www.cambridgeshire.gov.uk/highwayfaults](http://www.cambridgeshire.gov.uk/highwayfaults) or via the link on the Stukeleys Parish Council website.

Another resident requested clarification on the number of houses to be built at Alconbury Weald as MP Vince Cable had stated 7,000 houses were to be built, as there would be severe implications on infrastructure if the number of houses were increased. It was confirmed that Urban & Civil only have outline planning consent for 5,000 houses at the moment. The Huntingdonshire Local Plan 21,000 homes are planned to be built by 2036, and there are other possible development sites elsewhere. The Parish Council felt that Alconbury Weald would provide all the houses the Parish needed, but the Northbridge site was still a proposed site in the Local Plan. However, recent announcements of the closure of other air bases had not been taken into account in the Local Plan, as full details of the closures were not available.

Mr Brand of Abbey Group Cambridgeshire Ltd explained that the planning application 1402200FUL to be considered at this meeting was for extra solar panels. The original application left a small parcel of land to be developed at a later date, as there had been archaeological interest in this area when the first plan for the solar farm was considered. The panels will be fixed in this area in a different way so not to break the ground.

The Chairman of the Heartbeat Trust gave a presentation on the Heartbeat Trust Defibrillator Programme. The organisation is a charity not run for profit. He stated that defibrillators do save lives, there is a limited amount of time in which to save someone who has had a cardiac arrest, 10 minutes if CPR is used or otherwise just 5 minutes. A cardiac arrest can effect anyone, young, old, fit etc., and their chance of a recovery is increased from 12-17% to 50-80% if a defibrillator is used. To be effective a defibrillator needs to be available 24 hours a day, it can be stored in a vandal proof box with a key code lock. The code is logged with the ambulance service and if 999 is dialled the call handler will give out the code if appropriate. Defibrillators are very safe, the machine tells the operator exactly what to do and will only defibrillate if necessary. Training is available but the machine can be used without any training. Training sessions would be open to everyone who wished to attend. The machine should be located in a central place, accessible to the maximum number of people. A power supply is needed for the heating in the cabinet, the unit is battery powered. A defibrillator and stainless cabinet should last for 10 years. The machine will need to be regularly checked and a record of inspections keep. There was no data available on the lives saved by the use of a defibrillator in rural areas. A support/maintenance contract was available, which includes all consumables, batteries, and annual check. The East Anglian Ambulance Service are offering one free defibrillator, the representative from Heatbeat Trust is to check whether it would possible to obtain two free defibrillators as two individual villages make up the Stukeleys Parish.

The implications of the closure of the American Base at RAF Alconbury was discussed and it was felt that the closure of the base within 5 to 7 years would have implications for the Parish, Huntingdonshire Local Plan and the master plan for Alconbury Weald. HDC will be asked for



their views on the issue. However, the Parish and other interested parties would need to have a closure programme from RAF Alconbury, before implications could be fully considered.

A public meeting will be held on Monday 9<sup>th</sup> February at 7:30pm at Little Stukeley Village Hall, attended by Keeley Russell of Balfour Beatty to discuss current issues with the Balfour Beatty/CCC – Street Lighting Replacement Project with the residents of the Stukeleys.

The Parish Council considered a number of Village Projects. Following the Heartbeat Trust presentation it was proposed that the provision of a defibrillator for each village be considered as a community project, which would offer something for the community in regards of health and safety. The Parish Council agreed in principle to support the project and the options available are to be further investigated with consultation with both Village Hall Committees. Also providing broadband connection within the village halls were discussed and it was felt that this could be of benefit to the community and future users. The Parish Council is also investigating the possibility of providing real time bus arrival information for village bus stops.

The Parish Council's application for a bus shelter in Little Stukeley, to the Local Highway Improvement Initiative 2015/16 scheme was unsuccessful and have been advised that the Parish Council would not be able to eligible for funding from Adshel.

The possible provision on a dog run in Great Stukeley Playing Fields had not been a Parish Council initiative, but had arisen from a number of parishioner's requests. However, the meeting was advised that there would be no room in the Playing Fields for a dog run when the Football Association's recommendation for the size of a football pitch and run off was considered.

The Parish Council to report to CCC Rights of Way team that the footpath that runs past the allotments has a number of potholes (Bridleway 10-11 leading to Priestly Wood). Flytipping of rubbish at Owl End near the allotment bollards is to be reported to HDC. Flytipping can be reported to directly to HDC on 01480 388640 or via [www.fixmystreet.com](http://www.fixmystreet.com) or <http://www.huntingdonshire.gov.uk/> or via the link on the Stukeleys Parish Council website.

The Parish Council discussed the provision of an allotment central storage unit and other possible options. Cllrs Sue Parkin, Paul Vincent and Philip Hobson had declared an interest in this item and did not take part in any of the discussion or votes. It was stated that original planning application did include a provision for a possible central storage, however, the high cost for the building was questioned as to whether it would be of benefit to the community as a whole. Another Councillor felt that a central storage unit was how the original allotment was planned and would be a community asset. Ongoing costs and possible vandalism due the remoteness of the site needed to be considered. Individual sheds were discussed and whether they would make the allotments look untidy and disjointed. One Councillor felt that a central storage unit would be less imposing on the view from the countryside, but individual sheds of the same size in the central area would also not be a problem. Allotment holders could purchase their own sheds to a detailed specification and there would not be an issue with security and locking of a central storage unit. They would be lower in height than a large central building. However, the central storage unit was originally intended to be a central community hub. No proposal was carried therefore the issue was deferred to be discussed at the next meeting.

The following planning application was considered by the Parish Council:

- i **1401851FUL – The Old Rectory, Church Way, Little Stukeley** – Erection of stable building on existing grazing field adjacent to applicants dwelling. Following discussion and recommendation from the Planning Group it was **RESOLVED** to make no observations for or against, as there would be limited impact on the surrounding properties, St Martin’s Church and the Conservation Area.
- ii **H/5001/15/CW – Building 4002, Alconbury Weald** – Temporary change of use of building 4002 to an advanced biofuel demonstration centre. Following discussion and recommendation from the Planning Group it was **RESOLVED** to recommend approval as the application is entirely consistent with the aims of the Enterprise Zone and has no adverse impacts.
- iii **H/5000/15/CC – Alconbury Weald** – Erection of a primary school and nursery, ranging in height from one to two storeys; soft and hard play areas; sports pitches; car and cycle parking; landscaping and associated works. Following discussion and recommendation from the Planning Group it was **RESOLVED** to recommend approval as it was considered that the design was of high quality design and an essential facility for the proposed adjacent housing development, but also to refer to importance of the school being available to children from both The Stukeleys villages and to express reservations about car parking and drop-off.
- iv **1402200FUL – Land West of Railway Line and South of Brooklands Farm, Rectory Lane, Abbots Ripton** – Solar farm to include solar panels. Concern was expressed that the solar farm’s performance target may not have been met, but no data was available. It was felt that this planning application would have no adverse impact on the village. Following further discussion and recommendation from the Planning Group it was **RESOLVED** to recommend approval

## Dogs on Great Stukeley Playing Field

I write in response to Bumbling Bob's charge of lunacy at the Parish Council in respect of this issue.

"Bob" has no need of his sinister spy network. The suggestion to investigate whether it would be feasible to accommodate provision for local residents to exercise their dogs off-lead within the Playing Field area was discussed at a meeting open to all and at which he was present.

I put forward the suggestion after a number of our residents had asked if it would be possible to find somewhere easily accessible. Before even considering whether the cost would be value for money the first step was to see if it would be feasible, so the Parish Council had not yet thought of spending £'000s on this project. As "Bob" was present at the meeting he will have heard that a majority of parish councillors were sceptical, so it is wrong to imply that it was a "Parish Council" initiative.

When "pressed" "Bob" asserts that the Parish Council estimated TEN pouches might use it. Actually it was parish councillors themselves who asked this question. How many? Unknown really, but what I do know is that I pass this facility at least 4 times a day and rarely see anyone at all using the field, save for the occasional small child using the play equipment. It is mostly used by Stukeley Meadows Football Club - and how many Great Stukeley residents are in their teams?

Why provide this when we are surrounded by open land, "Bob" asks? Well, let us remember that all roads in our villages require dogs to be on leads. In our farmed countryside dogs should keep to the width of the footpath or bridleway and not run over crops or scare grazing livestock. A safe and fenced area would provide an alternative. Additionally, some elderly residents are not able to walk as far as some of us and would enjoy being able to socialise with other dog owners within the village while exercising their pets.

However, all this scaremongering from "Bob" was premature because a feasibility study showed it would not be possible to accommodate any such feature alongside the football pitch. I do not regret bringing this issue to the Parish Council but I am sorry not to be able to help those who sought it.

I believe that the Parish Council has a responsibility to ensure that the publicly owned assets of our villages are used to their maximum potential for the benefit of our community. Sometimes that requires thinking "outside the box" and questioning whether the status quo is the right option. I hope residents will not be intimidated by "Bob" and his charge of lunacy and will continue to bring forward suggestions as to how we might improve our villages.

I had no personal axe to grind on this matter - I am (reasonably) fit enough to walk two very lazy Greyhounds wherever and they have the benefit of a large garden in which to run around. Others may not be so fortunate.

### CHURCHYARD REGULATIONS

From time to time we are asked questions about the erection of memorials and the placing of flowers, or other forms of memorabilia, on or adjacent to graves in St Bartholomew's Churchyard. Mindful that this can be a delicate matter we felt it best to make things clear to all.

Regretfully, whilst most are aware of and comply with the regulations, some Funeral Directors fail to advise the bereaved appropriately or to take account of them when making an application for the erection of a memorial. Accordingly they do not necessarily give the best of advice at what we are well aware is a most sensitive time for relatives who have lost a loved one. Similarly, with the best of intentions, some families have placed mementos or planted trees or shrubs which are not compliant and thus outside of the delegated powers of an incumbent.

The regulations for the Church of England are laid down by the Chancellor of the Diocese and are published on the Diocesan website at

[http://www.ely.anglican.org/information/pdf/churchyard\\_regulations.pdf](http://www.ely.anglican.org/information/pdf/churchyard_regulations.pdf) or can be viewed as posted on the Church door in the South Porch.

**Under the Bearskin and The Royal Mews - Tuesday 12th May 2015**

The 1902 *State Landau* (or, State Postilion Landau) was specially built by Hoopers in 1902 for King Edward VII's Coronation. The King first travelled in the *Landau* in his state drive to the City of London on 25th October 1902. The large size of the King was taken into account in the coach's' construction so that he could sit comfortably.

The 1902 Landau is painted in a lighter shade of maroon than the other carriages and is richly adorned with gold leaf and upholstered in crimson satin. It also employs candle lit lanterns which are lit when the carriage comes out early in the morning. It functions as an open carriage drawn by six grey postillion horses.

The 1902 *State Landau* is the carriage IN MOST GENERAL USE which the Queen normally uses to meet foreign heads of state when they arrive on state visits to Britain. The Prince of Wales travelled to St. Paul's Cathedral in the 1902 State Landau for his wedding in 1981 returning in it with his bride, Princess Diana, after the service. The Duke and Duchess of York also used it for their wedding in 1986 and, most recently, it was seen at the wedding of Prince William and Catherine Middleton. On the day of our visit, after lunch at the Mad Hatter, we will be able to view the striking *State Landau* at the *Royal Mews*.

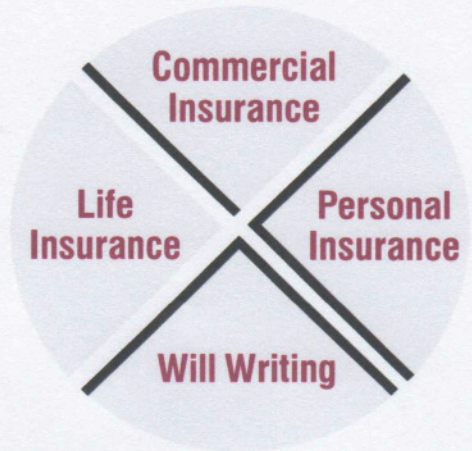



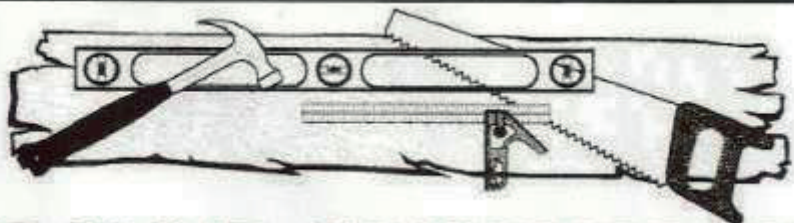
