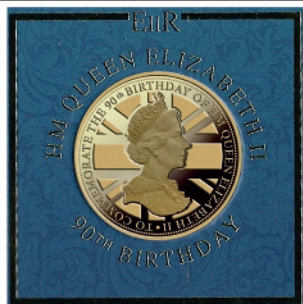

The Stukeleys Parish Council

The **Parish Council Meeting** was held on the 4th April at Little Stukeley Village Hall.

Following the recent A14 Parish & Community Forum meeting, it was noted that the current scheme did not incorporate lengthening and /or widening the access roads at the Alconbury interchange or widening the bridge roadway to accommodate the expected increased volume of traffic. Concern was expressed about the impact on the traffic using Ermine Street. The Parish Council expressed their frustration with the lack of progress being made with Ermine Street traffic calming scheme. These issues are to be raised with Urban & Civic.

It was reported that the crack to the repair in the carriageway south of the A14 over-bridge has now finally been repaired to a high standard. The Parish Council continues to report and chase CCC Highways to repair faults (potholes etc) in the village, but please remember parishioners can report faults directly by calling **0845 0455212** or via www.cambridgeshire.gov.uk/highwayfaults

The Parish Council considered the applications received from two candidates for co-optation as a member of the Stukeleys Parish Council. It was felt that both candidates had a number of different qualities, skills and experience that they could bring to the Parish Council, which would be of benefit to the community. A ballot was held and Michael Wormsley-Carter was duly co-opted as a Parish Councillor. The Parish Council thanked all the candidates for their interest in the Parish and Community.

The following planning applications and change to guidance note/conditions were considered by the Parish Council:

- i **Alconbury Weald, Ermine Street, Little Stukeley – 16/00454/FUL –**
Temporary change of use of land and buildings to mechanical plant training facility, including: erection of scaffold tower; erection of ‘Haki-shelter’ building; siting of storage containers; and siting of wheel washing unit. The Planning Group’s report was discussed and it was resolved to recommend approval as there was no adverse implications for the area and it was consistent with the extant planning permission for temporary uses. Urban&Civic and Huntingdonshire District Council to be asked to find an alternative and more appropriate form of address for Alconbury Weald.

- ii **Land East of Whiteleather Lodge, Wooley Hill, Ellington – 1001741/FUL –**
Erection of 4 three bladed wind turbines, up to a height of 130.5 metres,
and associated electricity transformers, underground cabling, two new
accesses to the site and new bridge, tracks, hardstanding, control building,
substations compound, met an communications.
The Planning Group’s report was discussed and it was resolved to make no
observations for or against.

A further meeting the HDC leader is to be arranged to discuss the implications of the
closure of the American base at RAF Alconbury. The Parish Council have informed
HDC that they wish to embark on developing a Neighbourhood Plan, which would
cover the entire Parish.

Update from Alconbury Weald

Over the last few weeks, Urban&Civic held 3 consultation events to share proposals for the £1m of enhancements planned for Ermine Street which aim to provide a more rural setting for the road, and in turn deter cars from driving through the villages as a “quick rat run”.

About 50 people attended the sessions and the feedback is currently being collated before a review by the engineering team, which will also take into account advice from a safety audit of the plans carried out by Cambridgeshire County Council.

Rebecca Britton, Communities and Partnerships, for Urban&Civic, said:

“We’re grateful for the time and views shared by everyone who came along. The feedback was generally positive about the principles with some useful suggestions on the detailed proposals. There were also a number of challenges raised which we will need to respond to. Many of the discussions focused on the extent to which the investment in the A14 and the detrunking of the existing A14 to create a local route to Huntingdon would have a positive impact on Ermine Street. People welcomed the phased, “monitor and manage” approach, which will allow regular review and enable further enhancements to be made if needed.”

The events came as the Urban&Civic team are gearing up to launch the first homes on to the market. Working in a joint venture with Hopkins Homes, Urban&Civic are preparing for a launch event on 16 and 17 April, where people will have a chance to look around the new entrance area, visit the Hopkins Homes sales centre and even reserve the first of the 128 homes being built in the first phase.

Rebecca added: “All of our contractors are working hard to put the finishing touches to the extensive investment in landscaping, which provide an attractive setting to the new homes. Work has finished on the water features and Causeway bridge, which is dressed with Clipsham limestone - the same limestone that has been used locally for centuries and can be seen in some of the villas on Ermine Street as well as the Church of St Martin’s in Little Stukeley. Over the next few weeks we will using some large pieces of kit to move trees from elsewhere on site into prime position in this entrance area. With the school continuing on programme for a September opening and the homes starting to come out of the ground, it is great to see the vision becoming a reality.”

Letter to Rebecca Britton from Martyn Redmore

ERMINE STREET ENHANCEMENTS

The Ermine Street Enhancement Plans can be viewed on the Alconbury Weald web site - it's worth a look. Comments were invited and I accepted the invitation. I accept that not everyone (indeed perhaps no one) will agree with my opinions, and they may well be ignored, but I felt moved to say something about what I had seen and read and sent my comments to Rebecca Britton. (The paragraph headings reflect the various sections of the plan but you may need to see the plans to understand some of the comments.)

Dear Rebecca,

A More Rural Environment!

One of the aims included in the Principles is: '*to give the road a more rural feel...*'. The dictionary defines 'rural' as: 'Places that are far away from large towns or cities.' Ermine Street is linked directly to a large town, it has light industry (with plans to extend) along much of its length, it will shortly have a new town (Alconbury Weald) and I believe there are plans to build yet another large estate opposite the Ermine Street Business Park. In addition, it is closely linked to and surrounded by a major road network, so the chance of the Stukeleys (or the road) ever becoming more rural is fairly remote.

Narrowing of the Carriageway.

It is difficult to gauge precisely the extent or effect of the proposed narrowing. Suffice to say that it will reduce the safety margins for road users - be they drivers of heavy goods vehicles, buses, cars, tractors and farm machinery, and even cyclists and horse riders. There is mention of eventual changes to the surrounding major road system being beneficial to pedestrians and cyclists, but I see no specific provision for cycle lanes in the plans for Ermine Street. The present system where cyclists share the pedestrian pathway in places can be hazardous at times, particularly for mobility scooters and pushchairs, and if more cyclists take to the pathway to avoid any enhanced risk by riding on a narrower road the situation will be even worse than it is now.

Removal of Bus Stop Bays.

Bus activity in each direction through the Stukeleys occurs only once an hour (with an additional less frequent community bus service); hence, blocking the road with a stationary bus should have a minimal effect on the overall traffic flow. Nevertheless, with potentially 3/4 stops of several minutes (us old folk don't move particularly quickly and pushchairs and fare payment take extra time) life could prove very frustrating for drivers who happen to be behind a bus as it enters the villages, particularly at busy times. It is perfectly reasonable that drivers will attempt to overtake the bus as soon as possible and as it is not easy to see around such a large obstacle there is a good chance that safety will be a major factor in any such action. Any risk will be exacerbated by the intended road narrowing. Your assertion (at the meeting) that the bus companies prefer not to use bus stop bays because it causes problems getting back into the traffic flow is merely a specious argument to support justification for their removal.

Change of Road Junction Priorities.

If I had been asked to design an accident black spot I think this would feature high on my list of proposals. One of your colleagues at the meeting assured me that a similar scheme works well in Northampton. Will it work here? It may well help to slow the traffic along the main road, but it will also introduce another element of driver frustration with its attendant increase in risk taking. We have all witnessed the propensity for some drivers not to indicate where they are going, especially when they have - or at least think they have right of way. Imagine several cars northbound at the southerly entrance to Church Road, Great Stukeley waiting to

see where cars coming in the opposite direction are going. Those cars coming south will not indicate left to show that they are going to continue straight on towards Huntingdon, and any one of those cars that may want to turn right into Church Road **need not** indicate because they will be turning in the direction of the priority traffic flow. Similarly, cars exiting Church Road North need not indicate to turn south towards Huntingdon. An identical situation would exist in Little Stukeley. I predict that accidents will happen if the junctions are changed as shown on the plans.

Reduction in the Amount of Transit Traffic.

One of the stated aims of the scheme is to reduce the number of vehicles transiting unnecessarily through the villages of Great and Little Stukeley. It would appear that no one has thought to find out where all of the transitees are coming from or going to, so the assumption that if we introduce multiple obstacles in their way it will change driver habits and they will suddenly all take a different route, is incomprehensible. Such a prediction takes no account of normal human behaviour. This momentous change seems to be predicated on the rerouting of surrounding main road traffic; however, it is doubtful if the rerouted A14 or the renamed A1307 will be active before the early 2020s. Meanwhile, from Spring 2018, there will be a large increase in the number of cars transiting from Alconbury Weald and all points North to Huntingdon and the various employment areas in between. I suggest that no one in their right mind will brave the route via Spittals during the rush hour. My conclusion is that, as a result of creating a 'new town' at Alconbury Weald and regardless of the proposed measures, traffic flow through the villages will continue to increase – contrary to statements made by Council representatives at past Parish Council Meetings, and that is something we will regrettably have to accept.

Traffic Calming.

Referring to the aim of reducing traffic through the villages, the stated Principles include: *'It was agreed that the best way to take this forward was not through traditional traffic calming of chicanes and ramps etc.'* Unless my interpretation of the scheme is incorrect, not only does it retain all of the current ramps and the gateway feature at the northern end of Little Stukeley, it **introduces yet another gateway** (similar to the one in Little Stukeley) at the southern entrance to Great Stukeley, **thereby contradicting your own principles.**

It is perhaps apposite at this point to comment on so-called traffic calming measures in general.

a. Ramps/Cushions. The majority of vehicles are capable of negotiating these devices (as currently designed) at speeds well in excess of the stated limit and they have little or no effect on those drivers who choose to do so. We see it frequently.

b. Gateways. (Blocking off one side of the road - as at the northern end of Little Stukeley)
If these devices were designed to cause mental frustration (as opposed to frustrating physical progress) they are a great success. The Little Stukeley installation is particularly successful during the evening rush when a continuous stream of traffic is leaving the village. Frustration breeds impatience, risk taking and a potentially hazardous mind-set. Southbound traffic can be stopped for several minutes and, depending on the vehicle in front, it can be very difficult to see if it is safe to pull out around the gated portion of the road. The process of stopping, waiting and starting involves additional wear and tear on brakes, clutch and gears, additional fuel consumption and (for the green lobby) additional air pollution. When there is no opposing traffic gated roads have little or no effect on those drivers determined to exceed the speed limit into and through the village.

The Little Stukeley Gateway and New Road Layout. In addition to the points above relating to gateways in general, it would appear that no consideration (risk assessment) has been given to the combined effect of the established gateway and revised traffic priority at the northern end of Little Stukeley that will exacerbate problems for motorists entering the village as they attempt to interpret what is happening some 50 metres ahead. They will not know if or when cars at the Mill Road/ Ermine Street junction are likely to move or stop, or whether a car is suddenly going to appear from Mill Road. Uncertainty over the intentions of other road users is not ideal and I believe this is a potentially hazardous situation that needs to be addressed.

'New' Great Stukeley Gateway. I have little doubt that the position of the proposed gateway at the southern end of Great Stukeley falls within the highway regulations, but the distance from the gateway to the crown of the left hand bend opposite Green End must be close to the limit for forward visibility. Vehicles waiting to enter the village could be faced with traffic suddenly appearing around the bend – probably at speeds in excess of 30 mph (they usually are). A car, (or worse - lorry or tractor), starting from rest and pulling to the wrong side of the road into oncoming traffic is a recipe for disaster, particularly in poor weather and on a wet surface. *(As an aside, I wonder if our ex-PM would appreciate a queue of cars just outside his property – braking to a halt then revving and accelerating as they negotiate this new obstacle on the road! I guess his gated entrance is not ideally positioned either).*

An Alternative Method of Traffic Control. I suspect most people's understanding of traffic calming mainly involves controlling traffic speed. I have a suggestion as to how that could be achieved without any of the proposals in this scheme and the concomitant safety risks involved. It seems reasonable to adopt the speed limits proposed. However, the gateway at Little Stukeley should be removed and the proposed new gateway at the southern entrance to Great Stukeley should not be installed. The speed cushions currently in place could be left in situ rather than spend money on their removal.

Those sections of the road subject to a 30 mph limit should be controlled by average speed cameras; a separate set for each village. There could be a small speed allowance over the limit (say 3 mph) for those drivers who claim to be unable to read the speedometer whilst looking where they are going, but otherwise any speed over the prescribed limit would incur an automatic incremental fine up to a specified limit. Heavy vehicles exceeding the 7.5-ton weight limit could be identified and fined. Not only would such a system calm the traffic but it would (I suggest) pay for itself and provide ongoing revenue for whichever authority was controlling it. Perhaps the £2m assigned for the current project could finance the initial installation! I suggested this solution at the presentation but was informed that the police would need to approve such a scheme. If that is the case, I suggest someone communicates with the appropriate authority to discuss the idea. Of interest, the police would no longer be obliged to commit finance and scarce resources to a speed check vehicle in the villages, and the inclusion of an ANPR device could aid crime detection and prosecution.

Summary. I have outlined a number of issues that could be detrimental to the quality of life for those living in our villages and potentially dangerous to those transiting through. In view of that, if the scheme is adopted, I would like to think that somewhere in the plan an individual can be identified as the 'Accountable Person' who would be responsible for any untoward eventuality. I look forward to your response.

Finally, whatever scheme is adopted, I wish it well and hope it will serve its purpose.

Parish Council Co-opt Vote

Exactly two years after I left my position as Clerk of the Council, I decided last Monday 4th April to attend a monthly Council meeting held in Little Stukeley Village Hall. I could see by the minutes and agenda provided, the professional status that my successor has brought to the proceedings, as I have said before Carole is doing a fine job even though she has the disadvantage of not living in the villages. I must comment though, it is still very evident by the number of issues that are still 'work in progress' that the Parish Council is still fighting a very difficult, uphill, battle to make their views heard, unfortunately according to what I heard success in matters relating to the development of Alconbury Weald seem to be very limited despite herculean efforts by certain PC members. Now I come to the main reason for this dialogue, 'Ageism'!!! During the course of the meeting an agenda item was 'The Co-option' of a new Councillor for which we were told there were two applicants, for the sake of ease, Applicant A from Great Stukeley and Applicant B from Little Stukeley. The resultant discussion took me 'aback'. I found it rather difficult as a 'Senior Citizen' myself to comprehend what I was hearing. During the discussion on the said Co-option the Vice Chairman was heard to say that he believed that both applicants could do a good job but that he felt that the Council should select the younger person, this idea was verbally supported by another member who also admitted that applicant B had a vast depth of knowledge on Parish issues, it was particularly noticeable that the two members with vast experience of working for 'higher' Local Authorities were very measured in their comments on the matter, with a further two members making no verbal comment at all. I find it totally reprehensible that a person's age should be the main topic of debate in the selection process, indeed I am uncertain whether in fact such reasoning is totally lawful. I have no problem with the subsequent secret ballot and the result thereof but take great exception to the nature of the debate that preceded this co-option. Furthermore, I think it highly worrying that our own 'local authority' uses this manner of debate to elect a new member to their Council. I also feel that an opportunity has been scorned to elect another member from Little Stukeley, one with such a wealth of experience and who was asked to stand by several members of this community in an effort to get some extra, meaningful representation on the Council, this is a village with no amenities whatsoever and needs a powerful voice on this local forum to ensure the villages needs and aspirations are fully represented. I find the entire episode a total disgrace and also I am mildly surprised the Clerk with her great grasp of Local Authority procedures did not remind members of the protocol surrounding the use of a person's age in the reasoning for election. It was a total joke and it has destroyed whatever confidence I ever had about the impartiality of the Stukeleys Parish Council. It is little wonder on this evidence that only 20% of the local electorate ever bother to vote!!

Parish Council Co-opt Vote - A Shambles!

I attended the Stukeleys Parish Council meeting on the 4th of April 2016 to make a point in regard to the Councils decision to ask for applications from the villagers to become a Parish Councillor. You would think the debate to be had would centre on the relevant experience that both candidates would bring to the table through either their professions or their knowledge of the villages or contacts in the wider community that could be called up to assist the Parish Council and hence the villages going forward.

Not a mention of it. Out of the seven Parish Councillors present two had nothing to say in the debate at all (shameful), one fudged the issue by stating they would vote for the Great Stukeley candidate because of housing numbers in each village should reflect the members of the Parish Council hence he would be voting for the Great Stukeley candidate. All ok`ish to this point. What came next I could hardly believe!

The Vice Chair voiced his opinion that age should be a consideration and they should vote for the younger candidate regardless of experience and virtues. This led to statements of agreement from at least three other Parish Councillors who all stated in varying degrees that they thought younger people should be on the Parish Council and although one candidate had a wealth of experience and the other did not they would vote on the premise of age and nothing less.

What is this country coming to? We now ignore people who have served the village for over fifty years, with a wealth of experience and contacts because of his age!!

I thought that age discrimination was outlawed in this country years ago and yet there we have our very own Parish Council, inclusive of a solicitor, voting purely on age grounds. What a farce. The whole Parish Council should be ashamed of itself and as to the Vice Chair goodness knows how he is to run the Parish Council in the new electoral year ahead. Woe betides anyone who goes along who is under the age of sixty is all I can say. A shambles Parish Councillors, a complete and utter **AGEIST** shambles!

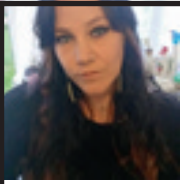

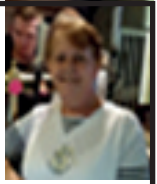

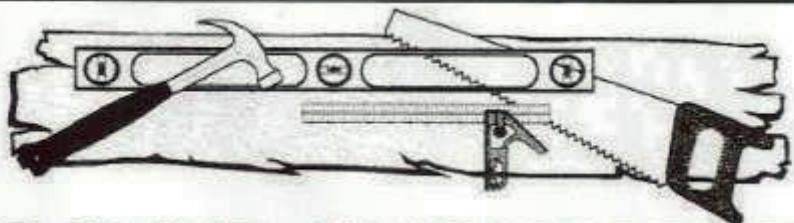
